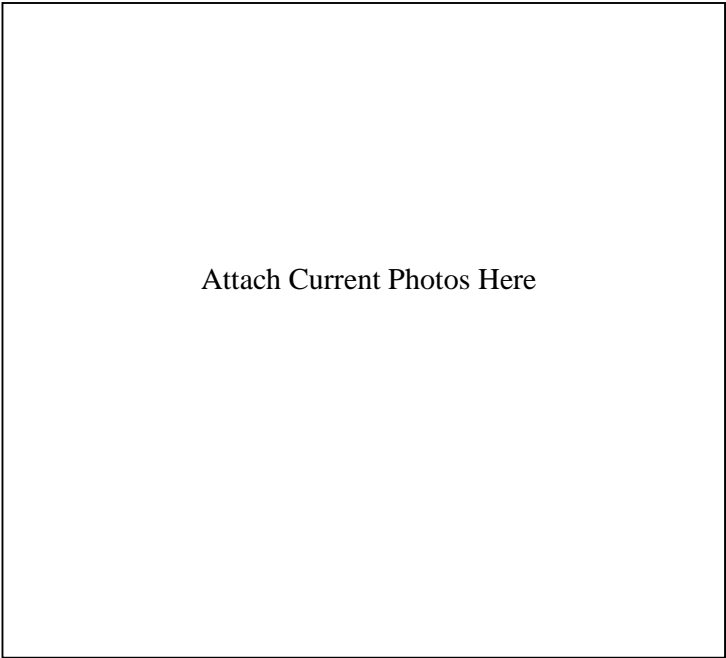

## **Toddler Pool Rules**

Toddler pool rules **must** be observed. Adults must always be present with their children. No children over the age of 5 are allowed in Toddler pool. Rubber pants are required, even over swim diapers, by children 3 and under to prevent accidents. Please remind all children to use the bathroom frequently. No jumping or diving into the pool with masks or fins or onto floating devices.

## **Pool Maintenance Contamination Issues**

Most of the time pool closure is due to contamination resulting from a child's "poop in the pool" accident. In order to prevent such accidents, please encourage your child to visit the bathroom frequently. Contamination is a serious and **preventable** disruption. It adds unnecessary expenses to pool operations: to meet health regulations, the pool must be shocked with chemicals and the pump must run continuously overnight for approximately 12 hours or as prescribed by the formulas dictated by the Santa Clara County Dept. of Environmental Health. **The pool is closed to all swimmers during this period.**

## San Jose Ordinance and Permit Requirements

Do not park in front of any residence or red zone. Use Baker School parking lots or streets adjacent to Baker School. Curb adjacent to pool property on Bucknall Rd. is for loading and unloading only. A second violation of parking rules will result in the loss of your membership. To comply with the San Jose Ordinance, there will be No Smoking anywhere on the premises of Westgate Cabana Club.

## Lifeguards and Safety

- The lifeguards are responsible for enforcing the Operating Rules and maintaining safety at the pool.
- No one will be permitted in the lifeguard's chair – with the exception of lifeguards or junior lifeguards.
- Parents are responsible for children in the Toddler Pool – no lifeguard is on duty for this pool.
- No one is allowed in the pool during open swim unless
  - a lifeguard is present OR it is posted that there is no lifeguard on duty and
    - swimmer is over the age of 14
    - if under the age of 14, the swimmer must be under the immediate supervision of his/her parent.
- The lifeguards will call *adult swim* at 45 minutes after each hour. At this time the lifeguard will leave the lifeguard post and fulfill other duties.
- Artificial swimming devices will be allowed at the discretion of the lifeguard. If the pool is crowded they will not be permitted.

## Swimming and Diving Safety

If you are not sure of your child's swimming ability, have him tested by the lifeguard(s) on duty. Note that this test can only be done during the 15 minutes of adult swim time so the lifeguards are not distracted from other swimmers. Often, a child who is not a strong swimmer tries to jump into a ring or use a kickboard at the deep end and can hurt himself because the swim aid bounces or the child can't hang on.

1. **To swim in the deep end a child should be able to swim the length of the pool.**
2. **Roughhousing and excessive dunking will not be permitted in or around the pool.**
3. **No water guns.**
4. **No diving or back-flips from the shallow end or from the side of the pool.**
5. **No jumping or diving into the pool with masks or fins or onto floating devices.**
6. **No swimming in diving area during dives. Divers must use the ladder or exit in the shallow end.**
7. **No one who is suspected of having an infection, cold, skin eruptions, sores, or any other contagious disease will be permitted to swim. Parents should self monitor this.**
8. **Parents need to monitor the bathroom needs and health of their children to minimize pool closures due to bodily discharges into the pool.**

## Gatewatch

The general responsibility for gatewatch duty is to verify membership with the membership book and to receive guest passes. It is also the responsibility during gatewatch duty to assist the Lifeguard or General Membership Families in the event of an emergency. In 2010, gatewatch duty is performed by Westgate Cabana Members.

## **General Rules**

1. **Each member must sign-in with the Gatewatch Person at the desk. Passes are required for non-members.**
2. **Walk bikes and carry skates and skateboards to and from the bike rack near the men's restroom.**
3. **No pets are permitted in the pool area.**
4. **No radios permitted without earphones.**
5. **Children may use chairs and lounges, but must relinquish them to an adult when asked.**
6. **Long hair must be tied back in a ponytail, braid, or swim cap.**
7. **Swimmers furnish their own towels, suits, and swim caps. There are no rental items. The club is not responsible for lost or stolen articles. Please leave your valuables at home. Check the lost and found regularly.**

## **Food and Parties**

- No glass wine or beer bottles. No glass of any kind is permitted. Use the recycling container for aluminum cans and plastic bottles (on covered patio, near drinking fountain).
- Food should be eaten away from the pool deck – either on the grass, benches, or tables. No gum or snacks with shells (sunflower seeds, peanuts, etc.) are permitted.
- The covered patio with the tables is available for rental for private parties. Members must not set up and occupy areas on and in front of the stairs to the covered patio. Ample space must be maintained for entering and exiting this area.
- If you have rented a party for the second shift, do not arrive early to set up and force the other party out. Give them time to finish and clean up.

## **Board of Directors**

A Board of Director position is held for a three-year term unless the current Director decides to terminate early. Elections are held each September for the upcoming year.
